### 1. Qualification Criteria/Eligible Bidders

- This Invitation for Bid is open to all registered Manufacturers/ Authorised Dealers. You should quote PAN , TAN , VAT & Registration numbers, Service Tax numbers, whichever is applicable and enclose certified copies.
- Authorized Dealers / Distributors / Importer who are quoting for the tender on behalf of manufacturers should submit copy of Dealership/ Distributorship/ Authorization letter from the manufacturer.
- The agencies/firm/company should have existed for minimum period of 5 years. Proof of existence should be attached
- Bidders should submit evidence of Order worth at least Rupees One lakh from a single customer in the previous financial year.
- Quoted rates should be valid for minimum period of **ONE YEAR** from the date of issue of offer by NCSCM



## 2. Bid Prices

- a. The rate must be in Indian Rupees.
- b. Bidders should furnish their Price Bid/Catalogue of Products both in MS EXCEL and in Print.
- c. All duties, taxes and other levies payable by the supplier shall be included in the total price.

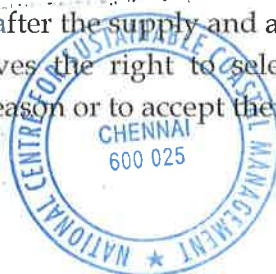
